**C- Relocation**

In the event of unavailability of the Hotel or in the event of force majeure, the Hotel reserves the right to accommodate some or all the participants at a nearby hotel of an equivalent class for services of the same nature. Any expenses connected with such transfer shall be supported by the Hotel and may not be subject to the payment of any compensation as a result of such transfer.

**D- Force Majeure**

The Hotel may be released of its obligations or suspend performance if impossible to carry them out as a result of the occurrence of exceptional circumstances or in the event of force majeure, specifically in the event of total or partial destruction of the establishment, strike, etc...

**E- Reservations, Cancellations, No-Shows**

Rooming list is required minimum 2 working days prior to arrival, excluding Saturdays, Sundays and Swiss bank holidays. Allotment, if any, will be automatically and irreversibly released if rooming lists are not received in due time and accordingly to the release period mentioned above (if applicable). Cancellations received within 72 hours will be charged to the company (1 full night).

No-show : one night charged to the company

**X. AGREEMENT AND SIGNATURE**



  - And when the present contract has been received duly signed.


