### Article 1 PARTIES OF THE AGREEMENT

### Article 2 SERVICE TERMS AND CONDITIONS / TARIFFS

Article 2.1. Special prices of the Hotel "River Side" being offered to ... are mentioned in the Article 3 of the given Service Agreement.

Article 2.3. Final booking will be made (confirmed) after receiving Confirmation Invoice from Hotel Reservation Department (Front Desk).

Article 2.4. Booking cancellation can be done 4 days before guest's arrival and in case of group reservation (5 rooms and more) 14 days before guest's arrival, otherwise Hotel is authorised to charge 30% penalty payment of the total amount. Hotel has this right in case of no show as well.

Article 2.5. Extra services (i.e. mini-bar, private car / taxi rent and special tour) is not included into prices mentioned in Article 3 of the given Agreement.

Article 2.6. The Hotel's service fee must be paid in 5 (five) days before starting providing service. In case of failure to pay in the given period, Hotel reserves the right to impose a fine of 1% of non-paid amount, for each overdue day.

Article 2.7 Hotel "River Side" authorizes another Party of the Agreement to be enrolled in River Side® Hotels Corporate Rewards Club. *Note: Separate Application form must be submitted.*

Article 2.8 In case of early departure of the guest(s) (before check out time mentioned in the reservation confirmation), the hotel service fee must be paid in full, according to the dates mentioned in reservation confirmation.
