The Tour Operator shall make all payments within the specified period in this contract.

3) General Sales Conditions:

- a) The agreed prices are NET, quoted in Euros, V.A.T. included, valid for individuals international leisure market (less than 8 persons) and for T.O. distribution. These rates cannot be presented directly to the client as room-only. The hotel has the right to terminate the present contract if the rates are not strictly applied according to this clause.
- b) Rates are per person and per night with buffet breakfast included (served at the restaurant), on the basis of single or double occupancy. They include free access to hotel's sport facilities (indoor pool, jacuzzi, sauna, fitness, outdoor tennis court and bikes). A local (city) tax of 2.50€ per person per day must be paid directly to the hotel by clients.
- c) Booking requests shall be made directly by the Tour Operator to the Hotel Reservations department: +33 (0)3 44 54 50 33 / email: reservations.montroyal@tiara-hotels.com. At booking time, the Tour Operator must indicate client's name, payment method, arrival date and time. Any further changes in client's name and/or details will be considered by the hotel as a new reservation request. Extra services, when not covered by the Tour Operator, will be directly charged to the client.
- d) Check-in time: from 3:00pm Check-out time: 12:00 noon Free outdoor parking
- e) Pets allowed with a daily supplement of 30€

f) Children room policy:

Baby cots available at no charge.

One child up to 12 years old sharing the parent's room is free of charge, room only (available from Deluxe category).

From 12 y.o. a daily supplement of 50€ (net hotel) is required to benefit of the Sofa bed available in all suites except Suite Deluxe with terrace and Royal Suite or to have an extra bed (available from Deluxe category)

g) Children F&B policy:

Up to 5 years old: breakfast is free of charge.

6 to 12 years old: 15 € /day

Children menu (6 to 12 years old): 30€ /day/child.

- h) Continental breakfast in room : 16€/perMONT ROYAL

- i) The Tour Operator shall confirm all bookings within the agreed period of time prior to the release date, in case of allotment. The allotment that has not been confirmed prior to the release date comes automatically available to the hotel, without notice and free of any charge.
- j) At any time during the contract, the hotel may interrupt the allotment or free-sale given to the Tour Operator.
- k) The hotel has the right to change the agreed prices, in case of tax variation, through written notice to the Tour Operator.
- Within the hotel premises, food and drinks not provided by the hotel are not allowed.

m) Cancellation policy:

Any cancellation request shall be "in writing" (mail, fax, email) to the hotel no later than 48 hours prior to arrival date.

Any cancellation received less than 48 hours prior to arrival: 1 night will be charged. No show: 100% of total stay will be charged.
