#### SPLIT SEASON RATE

For any reservations that commence in one season and overlap into another season during the guest's stay, the corresponding rate for each season will apply.

#### CHECK IN / CHECK OUT

Check in time is 15:00 hours and check out time is 12:00 hours. If you require early check in and / or late check out, the following additional charge will apply, based on the confirmed room rate of the night before:

Early Check in: before 08:00 hours 100% of room rate; from 08:00-10:00 hours 75% of room rate; from 10:00-12:00 hours 50% of room rate; from 12:00-14.00 hours 25% of room rate; as of 14:00 hours no extra charge

Late Check out: after 19:00 hours 100% of room rate; from 17:00 - 19:00 hours 75% of room rate; from 15:00 - 17:00 hours 50% of room rate; from 13:00 - 15:00 hours 25% of room rate; until 13:00 hours no extra charge

### ALLOTMENT / ROOM CONTROL PROCEDURE (if any allotment agreed)

All rooms on allotment must be sold and reported to Hotel immediately by fax/email along with arrival/departure details and meal requirements, as well as recapped at the cut-off schedule. Unsold rooms from allocation will be automatically released back to Hotel at the specified cut-off date. Requests after cut-off date are subject to rate and space availability. During high demand periods and in case the contracted rates are not available, the best available rate including 10% commission will be quoted. Company agrees that Hotel reserves the right to contact Company and to re-negotiate allocation in the event that actual or historical sales do not warrant the agreed allocation.

#### **CANCELLATIONS**

FIT: for low and mid-season: no cancellation fee will be charged for cancellations received by the hotel 24 hours prior to the day of arrival,

For high season: no cancellation fee will be charged for cancellations received by the hotel 48 hours prior to the day of arrival, in writing/fax or via telephone,

Fair Dates: Cancellation free of charge until 7 days prior to arrival, full stay will be charged when cancelled within 7 days prior to arrival.
