N.B: No written amendment to this agreement shall be taken into consideration apart from the signature on each page and information relating to tourist taxes and prepayment.

I) GENERAL TERMS AND CONDITIONS
--

1) TERM OF THE AGREEMENT

A. This agreement shall be valid only from 1 April 2017 to 31 March 2018 together with the price list of each hotel under contract (enclosed as an appendix hereto).

B. In order to be granted these special intermediary rates, sales targets will be given to the Tour Operator and these targets should be met by 31 October 2017.

Sales target for:

- Hôtel Barrière Le Fouquet's Paris: 100 room nights
- Hôtel Barrière Le Majestic Cannes: 100 room nights
- Hôtel Barrière Le Gray d'Albion Cannes: 100 room nights

The situation will be reviewed in November 2017 in order to decide whether the agreement should be renewed for a further year.

2) RESERVATION PROCEDURE

Reservations up to 9 rooms must be made exclusively through our reservation centre Brésa, by phone or mail:

The reservation must include:

- The guest's name
- Dates of stay (date of arrival and departure – number of nights)
- Type of room reserved
- Type of services reserved (B&B, half-board, etc.)
- Exact number of persons (number of adults – number of children + age)

Any modification or cancellation of a reservation must be confirmed in writing to Brésa and will be considered final after they have been confirmed by Brésa.

The Tour Operator undertakes to give the guest an exchange form or a voucher stating the services he/she has reserved, which he/she should hand to the hotel reception desk on arrival. **A sample of this voucher must be sent upon signature of this agreement.**

Reservations for groups (from 10 rooms) must be made directly to the hotels by phone or mail. Contacts are indicated on hotels' rates grids.

3) PRICES AND SALES

Our Frequent Individual Travellers rates ("FIT Rates") are net, non-commissionable, per room and per night and include service, VAT (value added tax), and breakfast and are attached hereto in the appendix. The VAT percentage included in the FIT Rates is the percentage applicable under French law at the date of this agreement. The FIT Rates are subject to modification in the event of a change of legislation concerning the percentage of VAT applicable in France as well as any new taxes which would be due by the customers or the contracted hotel(s).

These FIT rates shall be valid only if the name, location and at least one picture of the hotel covered by the agreement is contained in your brochure and/or website.

These FIT rates shall be valid for individual reservations up to 9 rooms per night.

FIT rates do not include city taxes.



A-Preferred rates confidentiality

The Tour Operator shall have full discretion to sell accommodation under the following terms and conditions:

- At any price it chooses when the rates are part of a “packaged product” (*as defined: created by adding Group Lucien Barrière contractual rates and any additional product*). In this case, the Tour Operator warrants and agrees that it shall not provide a breakdown of the cost of the packaged product so that customer rates can be calculated by a guest;
- Under no circumstances shall it disclose the component price for the accommodation services to the end customer;
- the **price shall be no lower than the Recommended Minimum Selling Price (RMSP)** published by Barrière Hotels for *B&B or golf package* products, whether this is contained in brochures or available online;
In the event of repeated breaches of this clause (more than twice), Group Lucien Barrière reserves the right to terminate this agreement.
- the Tour Operator shall ensure that all third parties to which the Tour Operator subsequently provides accommodation services undertake to comply fully with the entirety of this clause, and do in fact comply therewith.

B-Sales to third parties on and offline

The Tour Operator undertakes to advise the hotel before promoting or providing special rates to a third party for commercial purposes, including publication in brochures issued by a third party.

In any event, the Tour Operator shall only be permitted to sell [accommodation services] via Internet or a third party website provided it has the prior specific consent of Group Lucien Barrière, in writing. A copy of the agreement signed by the Tour Operator and the third party shall be sent to Group Lucien Barrière.

In the event of non-compliance with this provision, Group Lucien Barrière may terminate the agreement by giving the Tour Operator notice in writing. This termination will come into force on the date the Tour Operator receives a recorded delivery letter from Group Lucien Barrière referring to this provision and terminating the agreement. Such termination shall be without prejudice to any claim Group Lucien Barrière may make for damages.

The Tour Operator undertakes to ensure compliance with the RMSP by any such third party. In the event of non-compliance with the RMSP, Group Lucien Barrière shall be entitled to refuse to allow accommodation services in its hotels to be sold on this website and to duly inform all its partners of its decision. If, despite this, the third party continues to sell accommodation services of Group Lucien Barrière and fails to comply with rate parity, the agreement with the Tour Operator selling these rooms shall be terminated and this shall be solely due to the Tour Operator's failure to comply.

4) OTHER EXTRAS

Extra adult or child over 12 years old and/or extra green fees are to be paid by the Tour Operator.

All other extras such as half board, garage, and animal... are to be paid by the client on premises upon checking out.

Local taxes (subject to change at any time) are included in all our rates.

5) BROCHURE

The Tour Operator undertakes to reproduce, free of charge, one or more photographs provided by Group Lucien Barrière (the use of a trademark owned by Group Lucien Barrière shall be strictly limited to the scope of this agreement) and to submit a "final corrected proof" of the text and prices before it is published in its brochure and/or on its website. The hotel shall not be liable for publications that it has not approved.

As soon as the brochure is published, one copy should be sent to the hotel and another to the International Sales Department of Group Lucien Barrière, 35 Boulevard des Capucines, 75002 Paris.

6) AVAILABILITY OF ROOMS

Check in time: 3 p.m.

Check out time: before noon

7) TERMINATION

The Tour Operator's failure to comply with its contractual obligations shall result in the automatic termination of the agreement within 15 days after formal notice has been given by letter sent by recorded delivery (signed for) or in any other way providing proof of receipt of the notice of termination, without prejudice to any claims for damages. This shall apply in particular in the event of repeated failures (more than twice) to comply with the RMSP.

8) DISPUTES

This agreement shall be governed by French law. Any dispute that cannot be settled on an amicable basis between the two parties hereto shall be referred to the courts of Paris.

The allocated rooms guarantee to the partners the contracted rates. Once the allocation has been used, the partner can be granted the contracted rates for additional bookings only upon price confirmation by the reservation agent at time of booking. If the contracted rates are closed for the period of reservation and the hotel still have some availability, then the partner will receive a special net rate equivalent to the best flexible rate (daily rate) minus 20%, except **during Events Season**.

Commission will be payable after clients' departure upon receipt of a commission invoice.

2) CHILDREN

One child (under 12 years old) may stay in the parents' room on a B&B basis free of charge.

NB: Not all rooms can accommodate an extra bed. Availability should be checked when the reservation is made.

Not all triple rooms can add a baby cot. Please check on the enclosed rates sheet of the concerned hotel.

3) INVOICING AND PAYMENT

The hotel shall send an invoice with a value "net of commission" corresponding to **the pro forma invoice**.

The stay shall be paid for in full when the pro forma invoice is returned. Prepayment must be made one month before the customers' arrival at the latest. If customers are to arrive less than one month after the reservation, prepayment must be made in full by credit card when the reservation is made



If prepayment (by wire transfer or credit card) has not been received three weeks before the customers' arrival, the reservation will automatically be cancelled due to the Tour Operator's failure to comply with the terms and conditions of payment under the agreement.

4) TERMS AND CONDITIONS OF CANCELLATION

The hotel must be informed of a cancellation, in whole or in part, by email sent to Brésa: reservations.tope@lucienbarriere.com

If a confirmed stay is cancelled in whole, the hotel shall charge penalties in accordance with the terms and conditions stated in the appended price list.

5) NO SHOW

See information stated on the price list of each hotel covered by the agreement.

6) FORCE MAJEURE

Definition of "Force majeure"

A force majeure event and accidental occurrence shall be understood to mean all liability exemption causes arising from an unavoidable, unforeseeable event that is beyond the control of one of the parties where such event is not due to a fault or negligence by one of the parties.

Such liability exemption cause shall suspend performance of the parties' obligations hereunder and the deadlines and time limits contractually provided for shall be extended accordingly. If the liability exemption cause persists for more than three months, either party may terminate the agreement by letter sent by recorded delivery (signed for), unless the parties jointly agree to amend the agreement in view of the circumstances.

In the event of the prepayment of a customer's reservation, the reservation may then be postponed to a date within the next six months (with an adjustment of the price in the event of a change of season, and thus of the price).

If the customer does not wish to postpone his/her stay, the hotel then agrees to return the prepayment in full and shall not charge any cancellation fees.

If no prepayment had been made, no cancellation fees shall be charged.

III) TERMS AND CONDITIONS FOR GROUP SALES

Terms and conditions for group sales shall only be valid if both parties have signed the enclosed price lists and they shall apply to groups of 10 rooms or more.

Reservations should be made by e-mail to the hotel and must have been confirmed by the Group Reservation Department in order to be valid.

Reservations must be confirmed (or cancelled) **at least one month prior to the group arrival date**. Otherwise, the allocation reserved for this group will be automatically cancelled.

1. PRICES

Our Group rates are net, non-commissionable, per room and per night and include service, VAT (value added tax), taxes paid by customers or the contracted hotel and breakfast and are attached hereto in the appendix. The VAT percentage included in the Group Rates is the percentage applicable under French law at the date of this agreement. The Group Rates are subject to modification in the event of a change of legislation concerning the percentage of VAT applicable in France as well as any new taxes which would be due by the customers or the contracted hotel(s).



Our group rates are confidential.

Group rates do not apply to corporate customers. Prices for incentive meetings and conferences will be given on request.

2. SUPPLEMENTS

All supplements such as tourist tax, portorage and dinners will be included on the master invoice sent to the Tour Operator.

The hotel will charge the guest for any extras and supplements not included on the voucher. If one or more customer(s) that has used these services in addition to those included in the quote fail to pay the relevant amount, the hotel will charge the Tour Operator for such services. The Tour Operator undertakes to pay for these additional services no later than three days from the date of the invoice. The Tour Operator shall be responsible for claiming payment of such amounts from the customer.

3. ROOMING LISTS

Rooming lists should be received 10 days before the arrival date. Otherwise, the allocation reserved for this group will be automatically cancelled and the Tour Operator shall be charged the penalties stated in the price list.

4. FOOD AND BEVERAGES

Menu offers will be sent to you when the reservation is made. Coffee and tea are included in our rates. All other beverages are excluded unless stated otherwise on the proposal. Where applicable, selections made by customers from menus should be received 10 days before the arrival date.

5. INVOICING AND PAYMENT

The hotel shall send an invoice with a value "net of commission" corresponding to **the pro forma invoice**.

The stay shall be paid for in full when the pro forma invoice is returned. Prepayment must be made one month before the customers' arrival at the latest. If customers are to arrive less than one month after the reservation, prepayment must be made in full by credit card when the reservation is made

If prepayment (by wire transfer or credit card) has not been received three weeks before the customers' arrival, the reservation will automatically be cancelled due to the Tour Operator's failure to comply with the terms and conditions of payment under the agreement.

Payments of invoices should be sent directly to the hotel(s).

6. TERMS AND CONDITIONS FOR GROUP CANCELLATIONS

Reservations or modifications of reservations shall only be considered as firm and final after they have been confirmed by the Group's Reservation Department, which undertakes to reply within a maximum of 24 hours.

The hotel must be informed of a cancellation, in whole or in part, in a dated, written document.

If a stay is cancelled in whole, see the cancellation policies stated on the hotel's price list which is appended hereto.

If a stay is cancelled in part, and this cancellation is received seven days before the group's arrival, a cancellation fee of one night's stay will be charged.

7. NO SHOW

See information stated on the price list of each hotel covered by the agreement.



8. FORCE MAJEURE

Definition of "Force majeure"

A force majeure event and accidental occurrence shall be understood to mean all liability exemption causes arising from an unavoidable, unforeseeable event that is beyond the control of one of the parties where such event is not due to a fault or negligence by one of the parties.

If no prepayment had been made, no cancellation fees shall be charged.

This agreement shall be automatically cancelled if it has not been returned, duly signed, by October 31st, 2016.

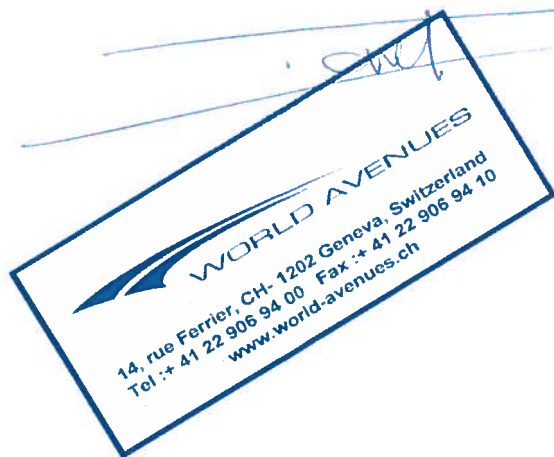
