- "Reservation Data" are the information personally recognizable (information that can be traced back to a specific client such as name, address, telephone number, mail address or invoice details) of any client booking a Room at the Hotel, through the Agent, as per this Agreement.
- "Hotel" stands for "Grand hotel via Veneto", located in Rome, in via V. Veneto, n. 155, which undertakes to make its rooms available, upon availability, to the Agent for the commercialization following this Agreement.
- "Taxes" stands for VAT and any other possible tax on sale and use of Hotel services, stay, on tenancy of goods and services.
- "Package only" stands for a Room sold in a package together with one or more elements that are related to the journey, such as flight tickets, car rent, restaurants reservations and/or exhibitions tickets.
- "Part" stands for, by the context, the Agent or the Hotel; collectively they are referred to as "Parties".
- "Room Only" stand for a Room made available individually and not as part of a "trip packet".
- "Rate" stands for the applicable rate to a certain class of Rooms and rules, including terms and conditions related to it, with no limitations: cancellation, pre-booking, "no-show", participation policy to fidelity programs.

## TERMS AND CONDITIONS OF THE CONTRACT

Representations / Guarantees - Each Party represents and guarantees to have company right or other legal right, power and authority in order to sign this Agreement and to comply with all its obligations, and that this Agreement constitutes legal obligation, valid and binding of that Party, practicable against that Party in accordance with its terms. The Hotel represents and grants that operates in compliance with Italian laws.

Contract duration / Term - The duration of this Agreement will start from the Effective Bate and will continue for reservations by Guests arrived up to the epa of its dualing termoexcept from earlier cancellation as for this Agreement. through the drawing up of a new contract. The Hotel has the right to rescind unilaterally this Agreement, in every moment, even before its arranged termination. The obligations of the Parties as per this Agreement that, by their own nature, would continue beyond its expiration term or the rescission date, included, without limitations, the responsibilities and the obligations, pondered before that term or expiration, will survive and every Party will maintain each and every right by the Italian laws in force.

Licence limitations - As per the terms and conditions of this Agreement, the Hotel will have the faculty to grant the Agent, exclusively in written form, the non-exclusive right and licence, royalty-free, for the duration of this Agreement, to use, reproduce or show, in any size, on the Agency Sites and on promotional material: (a) the logos, commercial names, service brands and logos ("authorized brands") and (b) images, photos or description (or any part of them) of the Hotel ("authorized contents") every time they are provided or made available to the Agent from or on the part of the Hotel itself. The Agent accepts not to make use of authorized Brands or Contents in a way that could be harmful or have a material impact affecting negatively the reputation associated to the authorized Brands, diminish their value or the company image, the activity or the Hotel reputation, even in an involuntary way.

Possible promotional materials produced directly by the Agent and containing what indicated under point a) and b) will have to be previously authorized, by the Hotel in written form.

**Room Access** - Through this Agreement, the Hotel gives to the Agent the non-exclusive right to make Hotel Rooms available for reservation by Clients of the Agent under the terms and conditions defined by this Agreement.

**Benefits** - The Agent agrees that the benefits within this Agreement are granted in exchange of, and depends from the adherence to this Agreement.

**Rate Policy** - the Hotel confirms that Room Rates offered to the Agent, as per this Agreement, are those indicated in the proposal and are to be intended net of commissions, for the Hotel. Any possible expense will be care of the Agent. It is agreed that the Agent will not, in any case, have the possibility to propose rates higher than those indicated in this Agreement. The non-observance of this latter clause will void this Agreement.

Availability - The Hotel has no obligation to allocate rooms in favor of the Agent

**Cancellation** / "No-Show" - The Hotel will accept possible cancellation made exclusively by the Agent and in no case by the Guest. In case of cancellation of late reservation or "no-show", a penalty corresponding to the entire stay rate will be applied, without any further communication.

**Stay extension** - In case that a Guest wishes to extend its stay beyond the date of his/her reservation, he/she will have to negotiate the rates and make the payment directly at the Hotel (according to availability). The Hotel will not be obliged to pay the Agent any additional cost nor it will be obliged to pay additional costs deriving for the extension of the stay.

Guests Data - Each Party accepts to own the reservation Data given to it directly or indirectly by any Guest or in the process of Reservation through the Agent's Sites or during the stay at the Hotel. With the only purpose of facilitating the process, the Reservation Data can be transmitted from one Party to the other, since: (a) each of the Parties is compliant with the law, rules and regulations in force and the current privacy policy; (b) possible revelations to third parties are made on the sole purpose of facilitating the above-mentioned reservation process, and under the strictest discretion.

**Confidential Information** - Confidential information of each Party are made by each and every piece of information and material revealed by the revealing Party to the receiving Party (in written, verbal, electronic or in any other form) that is signaled or identified as (or provided under circumstances reasonably indicating so) confidential or proprietary. Each of the Parties will maintain the confidential information of the counterparty under the utmost discretion and will not reveal those confidential information to third parties nor it will make use of these for other purposes, besides those indicated in this Agreement, without the previous written consent of the counterparty.

These restrictions will not apply to information otherwise confidential that (i) are already acknowledged by the receiving Party, (ii) becomes, not because of or by the action of the receiving Party, publicly known, (iii) are received by the receiving Party from a third party without a limitation on revelation or use, or (iv) are independently developed by the receiving Party without any reference to confidential matter.

**Force majeure** - No Party will be considered deficient or otherwise responsible as per this Agreement for the incapacity of observing its obligations in case of fire, earthquake, inundation, epidemic, incident, explosion, accident, strike, lock out, trade union dispute, revolt, disturbance of the public order, act of public enemy, embargo, any executive, administrative or judicial order (not resulting from acts or omissions that would constitute the non-fulfillment as per this Agreement), or any failure of electric energy or communication system or any other cause beyond the control of the said Party.

**Communication** - The communication under this Agreement will be given in writing and be delivered personally or through registered post or through express courier and sent, in the case of the Hotel, to the address indicated on the first page of this Agreement and, in the case of the Agent, to the address indicated on the first page of this Agreement. These communication will be considered successfully delivered: (a) upon receipt, if delivered personally or sent through registered post; (b) when the receipt is confirmed if the communication is sent through express courier or other mailing service.

Modifications / Derogations - Any modification of this Agreement will have to be notified in written form and signed by the Hotel and the Agent. In spite of the above, the Hotel can update the terms and conditions of this Agreement with a prior written notice sent by the Agent within fifteen (15) days. If the Agent does not communicate to the Hotel within the term of fifteen (15) days that it does not agree with those updated terms and conditions, these will be considered as accepted by the Agent. In the event that the Agent decides not to accept those terms and conditions, the Hotel will have the faculty to rescind this Agreement. It will not be made any derogation of any term and condition of this Agreement nor it will be justified any violation of the latter, except in the case that this derogation or justification have been communicated in written form by registered mail or have been executed by the Party against which this derogation or justification is claimed.

**Exclusions and guarantees** - The Hotel will not be responsible, in any way, of what is set by the Agent, towards the Guest and third parties that hold with the Agent relations connected with its activity.

**Enforceable Law / Place of jurisdiction** - The present Agreement is subject, in an exclusive way, independently from the place of subscription of it, to the Italian laws. For any dispute that may arise in relation to the content and execution of this Agreement and / or rooms sale and / or services of the Hotel made by the Agent following the signing of any other act and / or document, the competent authority will be the Judicial Authority of Rome, excluding the possibility of arbitrarian or different court.
