#### 7. INVOICING AND PAYMENT PROCEDURE

This Contract, once fully signed, shall commence on the first date hereinabove written 29th March 2017 and shall automatically expire on 6th April 2018 (the "Term"), unless terminated earlier as specified in this contract. Termination of this Contract shall not release the client from its payment obligation for any remaining dues to the Hotel.

- Payment for extra services (laundry, minibar, telephone, etc) and any other services requested individually by one or more guest shall be made at the reception desk by the guest themselves before their departure.
- All payments according to the specific agreed payment terms should be settled by bank transfers or credit card. 3. BANK: BRED, Agence de Serris Val d'Europe / RIB: 10107 00716 00822028427 24 IBAN: FR76 1010 7007 1600 8220 2842 724 / BIC: BREDFRPPXXX
- In case of payment by voucher, the company shall provide to the client vouchers with these mentions: Company name, the number of clients, their names, number of rooms, arrival and departure dates, number of nights, hotel name, half-pension, number of adults and children (one voucher per meal), type of room and promotion.
- Vouchers may be presented by the client at the hotel check-in, on arrival. Failing which, the client will be charged the amount of the hotel service at the public rate displayed in the hotel, and shall pay his bill prior to departure.
- Credit of 30 days: company payments must be received by the hotel within a maximum of 30 days of the clients' invoice
- Payment time: 7

Contractually, the payment time is fixed in 30 days date of invoice (except for seminar and groups, reception of invoice)

The Modernization of the Economy law of August 4th, 2008, applicable to concluded contracts since January 1st, 2009, reduced payment times inter-companies which cannot exceed 60 calendar days as from the emission date of the invoice, or 45 days end of month as from the emission date of the invoice. The non compliance with this law is punished by a 15 000€ fine.

To this is added a 40€ recovery costs per invoice not paid in time. The recovery cost is due from the first day of delay in the payment, without that a reminder is necessary.

To this is added a possible indemnity.

#### Late charges

The interest rate is fixed to 3 times the legal rate (European Central Bank reference rate + 10 pts.) and are calculated on the overdue debt. The late charges are due from the first day of exceeding, without that a reminder is necessary.

All the interest on overdue debt exceeding one year will be capitalized and added to the debt. Interests will be calculated on whole debt.

- Any bank charge resulting from a bank transfer is at the expense of the company
- No dispute or claim may be entertained unless the invoice is paid, then the dispute request form filled and sent with all back-ups necessary to Vienna House Magic Circus's accounting department. This dispute request form has to be sent within 15 days following the receipt of the invoice. If the dispute is justify, a credit note will be issued in your favour and will be deducted from a following payment
- 10. In the event of dispute, should the parties fail to settle on an out-of-court basis, the matter will be referred to the courts having jurisdiction over the location of Vienna House Magic Circus, the commercial court of MEAUX (France), French laws and French Language applicable.
- 11. By non-payment within the amount of time indicated and by late payment of over 30 days from the date of clients' departure, the hotel reserves the right to accept any and all future reservation only with an advance payment of 100%. Furthermore, the hotel has the right to cancel all agreed room contingent and refuse clients upon arrival.
- 12. Payment will be sent by scan email to the dedicated person contact and mail listed below. For each payment done, a statement has to be sent by email or fax to our accounting department - see below the contacts. This statement will list all the invoices paid.
